DURATION

The corporation shall have perpetual existence with an effective commencement date of November 14th 2005.

PURPOSE

- The general purposes for which the corporation is organized are:

 2. To transact any other lawful business activity for which corporations may be incorporated under the Florida General Corporation Act.






