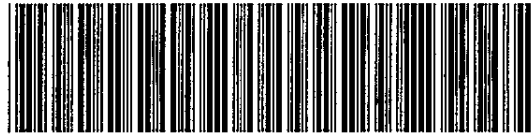

In compliance with the requirements of Chapter 607, Florida Statutes, the Florida Business Corporation Act, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I: NAME**

**ARTICLE II: PRINCIPAL OFFICE**

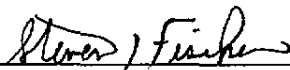
**ARTICLE VII: PURPOSE**

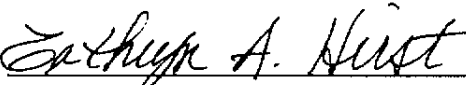
