ARTICLE ONE

The name of the corporation shall be FLORIDA POWER GENERATORS, INC.

ARTICLE TWO

The principal place of business and mailing address of the corporation is 607

Weldwood Road, Jupiter, Florida 33458. The duration of the corporation is perpetual.

The date and time of the commencement of corporate existence shall be immediately upon the filing of the Articles of Incorporation with the Secretary of State, Division of Corporations.

- (b) Any obligation that the corporation may issue or sell which is convertible into or exchangeable for any stock of the corporation of any class or classes, or to which is attached or pertinent any warrant or warrants or other instrument or instruments conferring on the holder the right to subscribe for the purchase from the corporation any shares of its stock of any class or classes.
