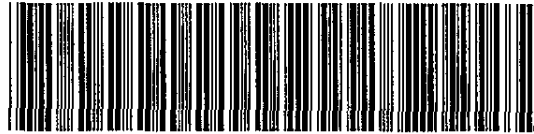

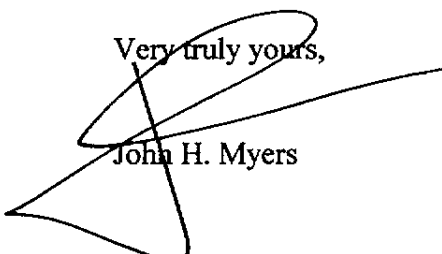

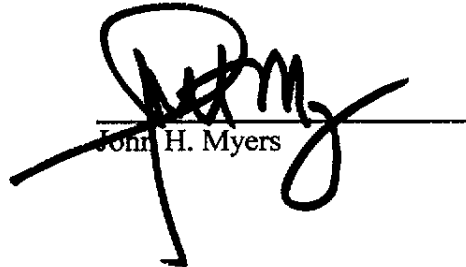
ARTICLE OF INCORPORATION
FOR

JOHN H. MYERS, P. A.

BY THESE ARTICLES OF INCORPORATION the incorporator forms a professional corporation for profit under Florida law.

- I. NAME. The name of the corporation shall be JOHN H. MYERS, P.A.
- II. TERM. This corporation shall exist perpetually.
- III. PURPOSE. The purpose of this corporation is to engage in every aspect of the practice of law in conformity with the requirements of Chapter 621 Florida Statutes.
- IV. CAPITAL STOCK. This corporation is authorized to issue 1,000 shares of common stock with a par value of \$10.00 per share.
- V. REGISTERED AGENT. The initial registered agent for this corporation is John W. Griffis, III, and the initial registered office is located at 2831 Ringling Blvd., Suite B-107, Sarasota, FL 34237.
- VI. DIRECTORS. This corporation shall have no directors. The business of the corporation shall be managed by the stockholders.
- VII. INCORPORATOR. The name and street address of the incorporator is John H. Myers, 2831 Ringling Blvd., Suite B-107, Sarasota, FL 34237.
- VIII. BYLAWS. After adoption of the initial bylaws by the stockholders, bylaws may be adopted, amended or repealed by the stockholders of this corporation.
- IX. STOCK RESTRICTIONS. By agreement, stockholders and this corporation may restrict or limit the sale or transfer, or both, of stock of this corporation, restrict the right to encumber the stock and provide for the consideration to be paid for the stock after its original issuance. The bylaws shall provide for transfer on the corporate books in conformity with any agreement.

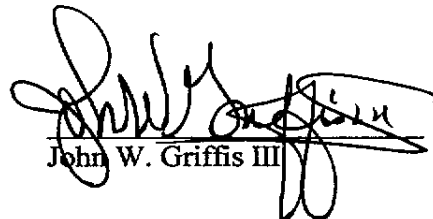
