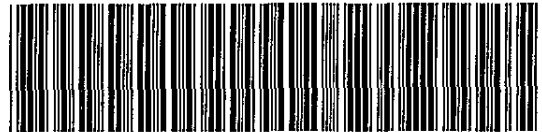

**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF  
SIX SIX ONE ML, INC.**

To: Department of State

Pursuant to the provisions of Fla. Stat. § 607.1006, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation is Six Six One ML, Inc.
2. The following amendments of the articles of incorporation were adopted by the incorporator of the corporation on November 18, 2005 in the manner prescribed by the Florida Business Corporation Act.
- 3 Article I is changed to provide that the name of the corporation is 661 ML, Inc.
- 4 The amendments were adopted by the incorporator without shareholder approval, as permitted pursuant to Fla. Stat. Section 607.1005, since the corporation has not yet issued shares.
