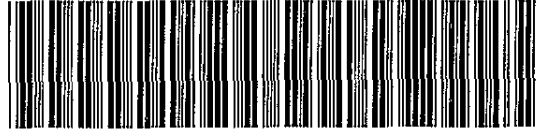

#### ARTICLE IX – INDEMNIFICATION

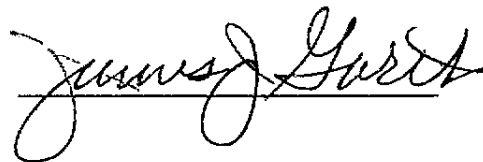
