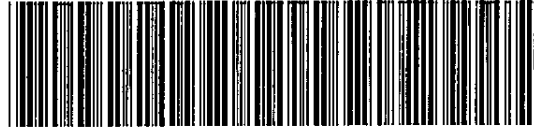

ARTICLES OF INCORPORATION
OF
SCOTT MOORE MARKETING, INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE
NAME

The name of the corporation is SCOTT MOORE MARKETING, INC.

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE
PURPOSE

The purpose for which the corporation is organized is to market time shares properties for profit.

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE FOUR
CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is one thousand (1,000), all of which shall be common shares with no par value.

ARTICLE FIVE
PREEMPTIVE RIGHTS GRANTED

REGISTERED OFFICE

ARTICLE EIGHT
DIRECTORS

The board of directors shall consist of one member, Scott R. Moore, 2037 Schulte Avenue, Daytona Beach, Florida 32118.

ARTICLE NINE
INCORPORATORS

The name and address of the sole incorporator is: Scott R. Moore, 2037 Schulte Avenue, Daytona Beach, Florida 32118.

ARTICLE TEN
OFFICERS

The sole officer of the corporation shall be Scott R. Moore, 2037 Schulte Avenue, Daytona Beach, Florida 32118, who shall serve as President/Treasurer.
