Pursuant to Chapter 607 of the Florida Statutes (the "Florida Business Corporation Act"), the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the corporation is TR GROUP HOLDINGS, INC. (hereinafter called the "Corporation").

ARTICLE II - INITIAL PRINCIPAL OFFICE

The aggregate number of shares which the Corporation shall have the authority to issue is 1,000,000 shares of Common Stock.


ARTICLE V - INITIAL REGISTERED AGENT
