ARTICLE OF INCORPORATION

OF

The undersigned incorporator hereby forms a corporation under Chapter 607 of the law of the State of Florida.

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name of the incorporation shall be:

Articles of Incorporation or any amendment hereof;

The foregoing paragraphs shall be constructed and enumerated both as objects and powers of the corporation, and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this corporation.

ARTICLE III

CORPORATE CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ONE HUNDRED (100.00) shares of common stock, each sharing the par value of ONE DOLLAR (\$ 1.00).

- i. All holders of shares of common stock shall be identical with each other in ever respect and the holders of common shares shall be entitled to have unlimited voting rights on all shares and be entitled to one vote for each share on all matters on which Shareholders have the right to vote;
- ii. All holders of shares of common stock, upon the dissolution of the Corporation,
 Shall be entitled to receive the net assets of the Corporation;
- iii. No holder of shares of common stock of any class shall have any preemptive right to subscribe to or purchase any additional shares of any class, or any bonds or convertible securities of any nature; provided, however, that the Board of Director (s) may, in authorizing the issuance of shares of stock of any class, confer any preemptive right that the Board of Director (s) may deem advisable in connection with such issuance:
 - iv. The Board of Director (s) of the corporation may authorize the issuance from time

to time of shares of its stock of any class, whether now or hereafter authorized, or securities convertible into shares of its stock of any class, whether now or hereafter authorized, for such consideration as the Board of Director (s) may deem advisable, subject to such restrictions or limitations, if any, as may be set forth in the bylaws of the Corporation;

v. The Board of Director (s) of the Corporation may, by Restated Articles of Incorporation, classify or reclassify any unissued stock from time to time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions of redemption of the stock.

Every shareholders, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which it already holds, shall have pre-emptive right to purchase its prorate share thereof, (as nearly as may be done without the issue of fractional shares), at the price at which it is offered to others.

ARTICLE VIII

INDEMNIFICATION

The corporation, upon a majority vote of the directors and shareholders, may indemnify director, officer, employee or agent of the Corporation against any and all suits, claims, or judgments, including attorneys fees and costs, to the fullest extend permitted by law.
