In compliance with the requirements of chapter 807, Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation is 800 East Developers, Inc. ("Corporation").



The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.


