
## ARTICLE X - LENGTH OF EXISTENCE

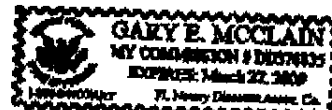
