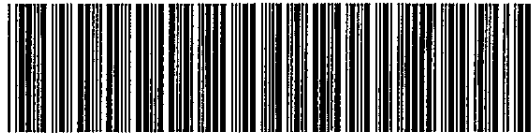



**ARTICLES OF INCORPORATION  
OF  
WINTON'S HOME-BUDDY, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation is: Winton's Home-Buddy, Inc.

**ARTICLE II**

The street address of the principal office of the Corporation is: 232 Chilson Avenue, P.O. Box 1317, Anna Maria, FL 34216.

**ARTICLE III**

The maximum number of shares this Corporation is authorized to issue is 100, par value \$1.00 per share, all of which shall be Common Shares. 


