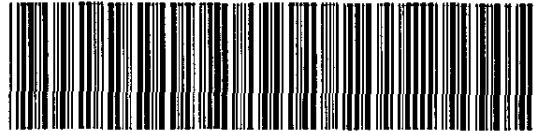

The name of this corporation is RCH ARTS, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the first day of January 2006.

ARTICLE III - PURPOSE

This corporation is organized for the purpose off transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.
