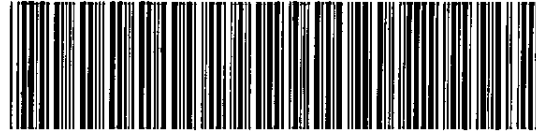

THIS IS TO CERTIFY that I, the undersigned, for the purpose of forming a corporation under the provision of Florida Statutes 1985, Chapter 607, and statues amendatory thereof and supplementary thereto, do hereby make, subscribe, acknowledge and file these Articles of Incorporation, as we do certify that:

1. The name of the corporation is: PRIVATE SUPPORT SERVICES, INC.

2. The major purpose of the corporation will be to engage in the business of Private Investigations.

In addition, the general nature of the business transacted shall be:

To engage in any one or more of the businesses and to exercise any and all powers authorized and permitted by the said statutes to corporations formed there under.
