ARTICLES OF INCORPORATION OF PETER R. RAY, P.A.

THE UNDERSIGNED incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - Name and Address

The name of this Corporation is: PETER R. RAY P.A., and the principal place of business and mailing address is 712 U.S. Highway One, Ste 400, North Palm Beach, Florida 33408.

ARTICLE II - Commencement and Duration

This Corporation shall commence on the **DATE OF FILING** of these Articles and the duration of this Corporation is perpetual.

ARTICLE III - Purpose
