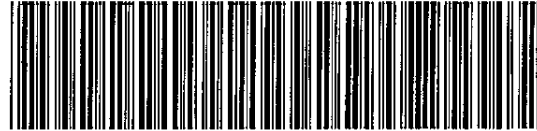

ARTICLE I

NAME

The name of the corporation is CENTURY MAX, INC.
