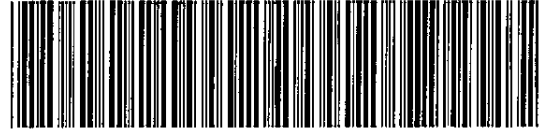

THE UNDERSIGNED, subscriber to these Articles of Incorporation, is a natural person competent to organize a corporation for profit under the laws of the State of Florida.

ARTICLE I NAME

The name of this corporation is MELANDA, INC.

ARTICLE II NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III CAPITAL STOCK

1. The number of shares of authorized capital stock of this corporation shall be five thousand (5,000) shares of capital stock having no par value. The minimum amount of state capital with which the corporation shall commence business is Five Hundred (\$500.) Dollars.
2. The capital stock may be paid for in property, labor or cash at a just valuation to be fixed by the stockholders. All of such shares shall be fully paid and nonassessable.

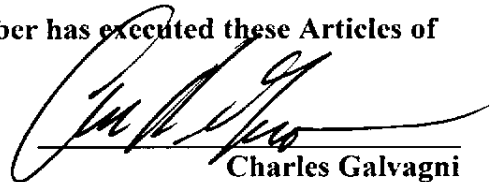

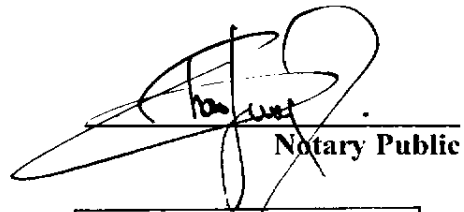
