ARTICLES OF INCORPORATION  
OF

ARTICLE I. - CORPORATE NAME

The name of this corporation is:

ODIN CORP.

ARTICLE II. - NATURE OF BUSINESS AND POWERS

This Corporation is organized for the purpose of transacting any lawful business.

ARTICLE III. - CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock of no par value per share.
