The undersigned, subscribers to these Articles of Incorporation, are natural persons, competent to contract, and they do hereby present these Articles for the formation of a corporation under the Laws of the State of Florida.

ARTICLE

The name of this corporation is: TRADING PLACES REALTY NETWORK, INC.

ARTICLE II NATURE OF BUSINESS

The general purposes for which the Corporation is organized are the following:

A. Real estate Company.

B. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

C. To do such other things as are incidental to the purposes of the Corporation or

necessary or desirable in order to accomplish them.

ARTICLE III CAPITAL STOCK

No contract or other transaction between this Corporation and any other Corporation, and no act of this Corporation shall in any way be affected or invalidated by the fact that any of the officers of this Corporation are pecuniary or otherwise interested in, or are Directors or Officers of, such other Corporation; any Director individually, or any firm of which any Director may be a member, may be a party to, or may be pecuniary or otherwise interested in any contract or transaction of this Corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, and any Director of this Corporation or who is so interested may be counted in determining the existence of a quorum at any such meeting of the Board of Directors, and may vote at any such meeting of the Board of Directors, and may vote at any such contract or transaction, with like force and effect as if he were not such a Director or Officer of such other Corporation or not so interested.
