

ARTICLES OF INCORPORATION OF

The undersigned subscriber to these articles of Incorporation, a natural person competent to contract and legally authorized to practice the profession of <u>ATTORNEY AT LAW</u> in the State of Florida, hereby proceeds to form a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

CORPORATION NAME

The name of this corporation is RONALD ANDERSEN HURST, JR., P.A.

ARTICLE II
