ARTICLE I. CORPORATE NAME.

The name of this Corporation is: **CORAL REEF CONTRACTORS, INC.**

ARTICLE II. ADDRESS OF PRINCIPAL OFFICE.

ARTICLE III. NATURE OF BUSINESS AND POWERS.
