CERTIFICATE OF INCORPORATION
OF

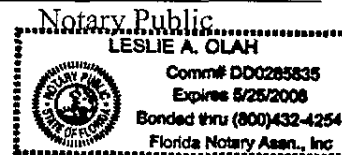
