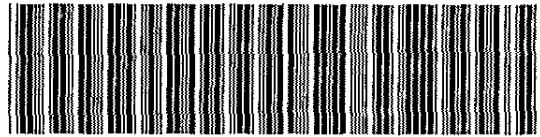

**CHANGE OF REGISTERED AGENT/REGISTERED OFFICE:**


Arlyn Garcia Claro is hereby deleted as the Registered Agent of the corporation.


