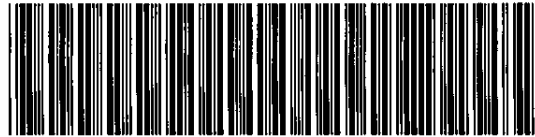

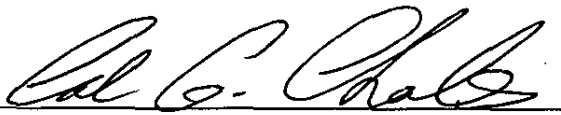
SECOND: The date of the adoption of these Articles of Dissolution is 18 April 2006.
