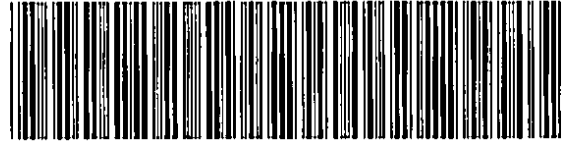

**ARTICLES OF DISSOLUTION
OF
