ARTICLES OF INCORPORATION

- I, the undersigned, ANTHONY FAVARA do hereby prepare these Articles of Incorporation for the purpose of forming a corporation for profit as provided under the laws of the State of Florida.
- 1. NAME. The name of the corporation shall be PEACE RIVER CUSTOM HOMES, INC.
- 2. **PURPOSE.** The said corporation is to be in the business of engaging in any and all activities allowable under the laws of the State of Florida.
