The undersigned subscriber to these Articles of Incorporation a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME

The name of this corporation is:

#### ARTICLE II - DURATION / TERM OF EXISTENCE

#### ARTICLE VII AMENDMENT

These articles of Incorporation may be amended in the manner provided by law. 3. No shareholder of the Corporation may sell or transfer his stock in this corporation except to another individual who is eligible to be a shareholder of the corporation.

#### ARTICLE IX POWER OF CORPORATION

The Corporation shall have the same powers as an Individual to do all things necessary or convenient to carry out its business affairs, subject to any limitations or restrictions imposed by applicable law or these Articles of Incorporation.
