ARTICLES OF INCORPORATION

OF

ARTICLE I

The name of this corporation is JOE I. PETITT, INC.

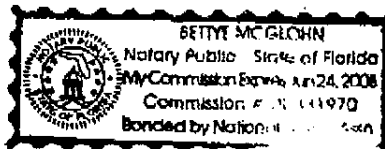
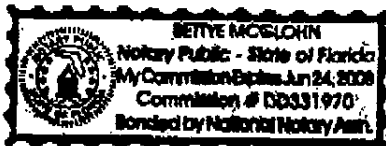
