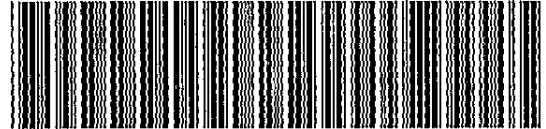

CUMULATIVE VOTING



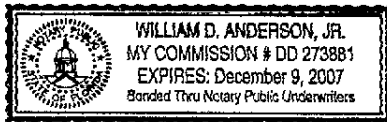

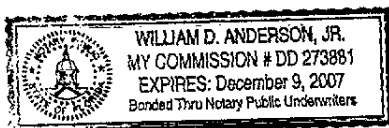
