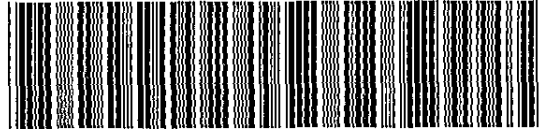


ARTICLE VIII
