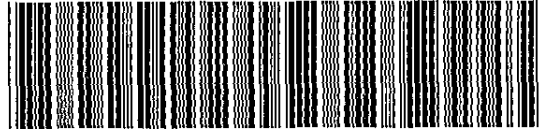

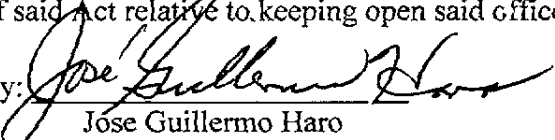
ARTICLE VIII
