

ARTICLES OF INCORPORATION OF
RICKY NATTIEL, P.A.

1. The name of this Corporation is **RICKY NATTIEL, P.A.**
2. The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida. The purposes for which this Corporation is organized includes the purpose to arrange for the trade, purchase and sale of real property, and to act as agent for others who want to accomplish the same.
3. The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1000 shares of common stock, having a par value of \$1.00 per share.
4. This Corporation shall have perpetual existence commencing upon filing of these Articles.
5. The Registered Agent and the street address of the initial registered agent of this corporation in the State of Florida shall be: FONDA R. BUTKIEWICZ, 1918 SE 17th Street, Ocala, Florida, 34471, who by signature herein is accepting designation as Resident Agent.
6. The initial stockholders will be as follows:

FONDA R. BUTKIEWICZ	500 Shares
RICKY NATTIEL	500 Shares

Shares held by each shareholder may not be sold or otherwise transferred to other persons or other entities, except as follows: a) sold back to the corporation at a price agreed to between the seller and the remaining shareholders, or if no price is found agreeable then at a price as determined by an independent appraiser; or b) to any other existing shareholder at mutually agreeable terms. No share shall be conveyed, split, or transferred, if such action would violate the federal prescriptions for an S corporation, as provided by law in effect at the time of proposed action.


7. The initial offices and officers shall be as follows:

FONDA R. BUTKIEWICZ	President
RICKY NATTIEL	Vice-President
JAMES R. BUTKIEWICZ	Secretary-Treasurer




8. The business of this corporation shall be managed by the stockholders of the corporation, rather than by a Board of Directors.

12. The principal place of business shall be 1918 SE 17th Street, Ocala, Florida, 34471.
13. The President, the Vice President and the Secretary/Treasurer, acting in their sole capacity, have the authority to sign contracts, checks, receipts and otherwise conduct business on behalf of the corporation.




