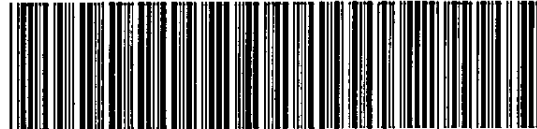

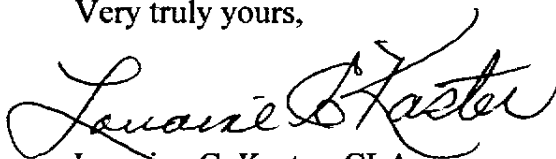

ARTICLE I - Name

The name of the corporation shall be: **S & S BLUE SKY AVIATION INC.**

ARTICLE II - Duration

This corporation shall exist in perpetuity commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business, including, but not limited to the following: Airplane transportation, renting and leasing of hanger facilities, for company related business, private sources and all related operations.

ARTICLE IV - Capital Stock

This corporation is authorized to issue One Thousand (1,000) shares of Ten Cents (.10) par value common stock which shall be designated "Common Shares."

ARTICLE VIII - Principal Place of Business

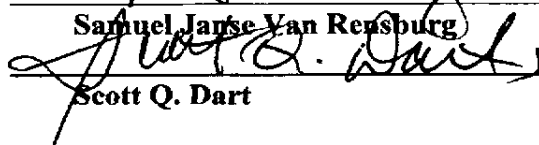
