Mr. Smude is out of the country for several months and his assistant contacted us concerning the annual report for 2007, as a result of a notice she received in his absence.

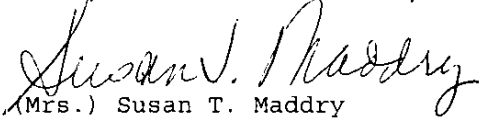
