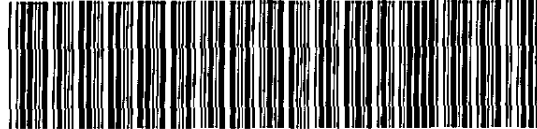

Articles of Incorporation of

ARTICLE I.

NAME

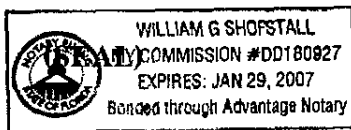


