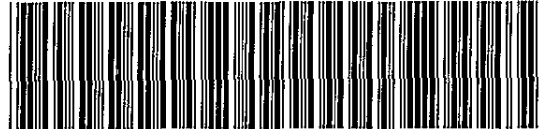



Article XIII - Amendment



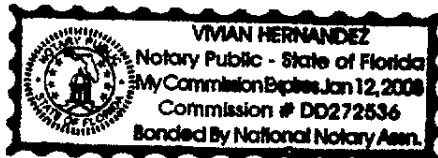
