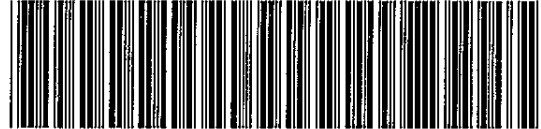

ARTICLE I - NAME

The name of this corporation is JOHN HEALEY, P.A.

ARTICLE II - DURATION

EFFECTIVE DATE

1-1-06

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business. The specific nature of the business is for real estate sales.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1000 shares of common stock having a par value of \$1.00. There shall be only one class of stock.

ARTICLE V - PREEMPTIVE RIGHTS


