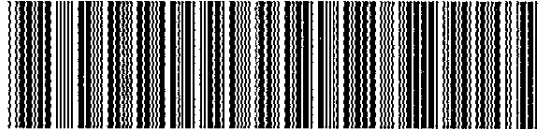

The power to adopt, alter, amend or repeal bylaws shall be vested the board of directors.


ARTICLE X - INDEMNIFICATION


