

ARTICLE I- NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this corporation is TRUTH TRIM CARPENTRY, INC. and its principal place of business shall be located at P.O. BOX 561, AVON PARK, FL 33826-0561

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business and shall be designated as an "S" corporation.

ARTICLE IV- CAPITAL STOCK

This corporation is authorized to issue 100 shares of common stock, with an assigned value of \$1.00 per share and shall designated as Common Shares. All shares of stock shall be owned by Robert Lee Giles.

ARTICLE V- PRE-EMPTIVE RIGHTS
