XII.


Bylaw Amendment

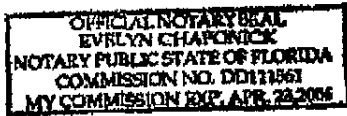


