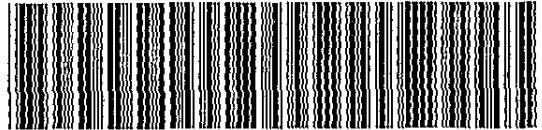

**ARTICLES OF INCORPORATION  
FOR  
WRIGHT'S BUILDING CONNECTORS, INC.**

The undersigned, for the purpose of forming a corporation for profit under the Florida General Corporation Act, hereby do adopt the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation is **WRIGHT'S BUILDING CONNECTORS, INC.**

**ARTICLE II**

**TERMS OF EXISTENCE**

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles or upon filing with the Secretary of the State of Florida, in the event these Articles are not filed within five (5) days, exclusive of legal holidays, after execution and acknowledgment.

**ARTICLE III**

**NATURE OF BUSINESS**

The general purpose for which the corporation is organized are:

- (a) To operate and function as a building construction and repair business.
- (b) To carry on such other business as may be necessary, convenient, or desirable to accomplish the purpose stated in paragraph (a).
- (c) To transact any other lawful business for which corporations may incorporated under the Florida General Corporation Act or engage in any other trade or business which can in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

**ARTICLE IV**

**CAPITAL STOCK**

The aggregate number of shares which the corporation is authorized to issue is 1000. Such shall be of a single class, and have a par value of one (\$1.00) dollar per

share.

Each holder of the Common Stock shall be entitled to one vote for each block of shares of stock standing in his name on the books of the corporation. Voting rights will be the same no matter how much you invest. This does not hamper the profit share.

No stockholder shall have the right to sell, assign, pledge, encumber, transfer, or otherwise dispose of any of the shares of the corporation without first offering such shares for sale to the corporation without at no more than what his total profits were the previous year. Such offer shall be in writing, signed by the stockholder; shall be sent by registered or certified mail to the corporation at its principal place of business; and shall remain open for acceptance by the corporation for a period of thirty (30) days from the date of mailing. If the corporation fails or refuses within such period to make satisfactory arrangements for the purchase of shares, the stockholder shall have the right to dispose of his shares as he may see fit.

On the death of any stockholder, the corporation shall have the right to purchase all shares owned by such stockholder immediately prior to his death on the terms set forth above, and this provision shall be binding on the executor, administrator, or personal representative of each stockholder.

Each share certificate issued by the corporation shall have printed or stamped thereon the following legend: "These shares are held subject to certain transfer restrictions imposed by the Articles of Incorporation of the corporation. A copy of such Articles is on file at the principal office of the corporation."

#### **ARTICLE V**

##### **ADDRESS**

The address of the principal place of business of this corporation shall be: 5612 Meridian Way, Orlando, Florida 32808 with the privilege of having branch or other offices or shops at other places withing or without the State of Florida. The name of the initial

registered agent is Wilbur V. Chaney, Esquire, 75 Southwest 5<sup>th</sup> Avenue, Delray Beach, Florida 33444.

#### **ARTICLE VI**

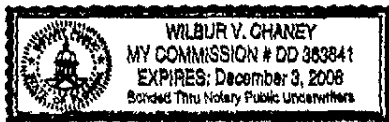
