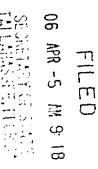

Pursuant to Section 607.1006 of the Florida Statutes, the Articles of Incorporation of **FORLUG HOLDINGS INC.** (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is FORLUG HOLDINGS INC.

SECOND: Article IV of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows.

ARTICLE IV

The number of shares the Corporation is authorized to issue is 500 Class A Voting and 500 Class B Non-Voting and all classes of shares of the Corporation (including Class A Voting and Class B Non-Voting shares) shall confer identical rights to distribution and liquidation proceeds.
