ARTICLES OF INCORPORATION

The undersigned incorporator, MICHAEL I. WADE, a natural person competent to contract, hereby presents these Articles of incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

### ARTICLE 1 - NAME
