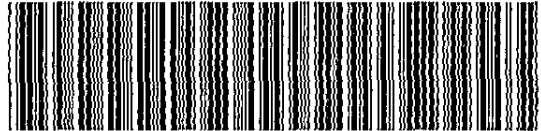

ARTICLES OF INCORPORATION

JEFFREY GARCHIK, P.A.

The undersigned Incorporator, who is licensed and otherwise legally authorized to perform the service of a real estate salesman in the State of Florida, hereby forms a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, and adopts the following Articles of Incorporation for the Corporation.

ARTICLE I. NAME

The name of this Corporation is JEFFREY GARCHIK, P.A.

ARTICLE II.

PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT

The address of the Corporation's principal office is 806 Cypress Grove Lane, #312, City of Pompano Beach, County of Broward, State of Florida 33069, and the name of the initial Registered Agent of this Corporation at that address is JEFFREY GARCHIK.

ARTICLE III. DURATION

The Corporation shall commence upon the filing and acceptance of these Articles of Incorporation and exist until it is dissolved on a vote of the Shareholders as provided in these Articles.

ARTICLE IV. PURPOSE

The purpose of the Corporation is to perform the sole and exclusive professional service of a real estate salesman in accordance with F.S.A. §475 et seq., as amended.

ARTICLE V. CAPITAL STOCK

The total number of shares of stock that this Corporation is authorized to have outstanding at any one time is 1,000 shares. These shares shall be of a single class of common stock, and shall have a nominal, or par value, of \$1.00 per share.

ARTICLE VI. CORPORATE POWERS

The Corporation shall have all the rights and powers now or subsequently conferred on professional corporations by the laws of the State of Florida, including, but not limited to, acting as a real estate salesman pursuant to F.S.A. §475 et seq., as amended.

ARTICLE VII. INCORPORATOR

The name and street address of each person signing these Articles of Incorporation is:

ARTICLE VIII. INITIAL DIRECTORS

The Corporation is to be managed by a Board of Directors. The number of Directors constituting the initial Board of Directors is one (1), and the name and address of the initial Director of this Corporation is:

Pompano Beach, Florida 33069.

The initial Director shall hold office until his successor is elected and qualified as provided in the Bylaws. Then the term of office of each Director shall be for one (1) year or until the election and qualification of a successor or successors. The number of Directors set forth in these Articles of Incorporation and constituting the initial Board of Directors shall be the authorized number of Directors until that number is changed by a Bylaw duly adopted by the Shareholders.

ARTICLE IX. RESTRAINT ON ALIENATION

No Shareholder may sell or transfer his shares in the Corporation except to another individual who is eligible to be a Shareholder of the Corporation under Florida law.

ARTICLE X. BYLAWS

The initial Director shall submit the proposed Bylaws to the Shareholders at a meeting to be held for that purpose not more than two (2) days following the issuance of the Certificate of Incorporation. Following the adoption of Bylaws by the affirmative vote of the holders of all of the outstanding shares of the Corporation entitled to vote, the internal affairs of the Corporation are to be regulated and managed in accordance with the Bylaws.

ARTICLE XI. DISSOLUTION

The Corporation may be dissolved at any time by unanimous written consent of the Shareholders. On dissolution, the corporate property and assets shall, after repayment of all debts of the Corporation, be distributed to the Shareholders pro rata, each Shareholder to participate in the distribution in direct proportion to the number of shares held by the Shareholder.

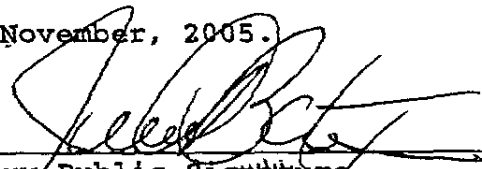

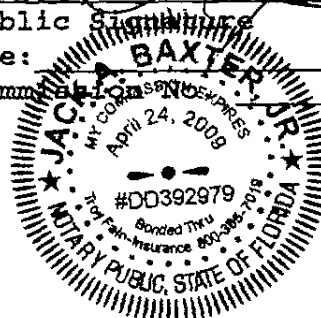
