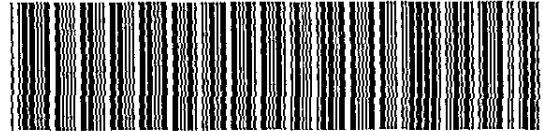

**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is JOSEPH YOUNG P. A. and its principal place of business shall be located at 15770 Menton Bay Ct. Delray Beach, Fl. 33446

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business as a licensed Realtor.

**ARTICLE IV - CAPITAL STOCK**

or failed to perform his duties as an officer or director as provided §607.0831, Florida Statutes (1990).

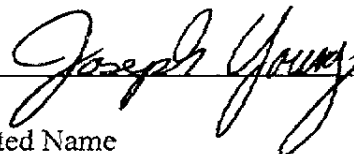
#### ARTICLE XI - AMENDMENT

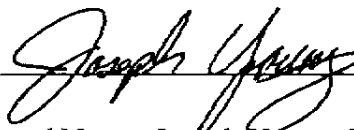
