Initial Registered Office and Registered Agent

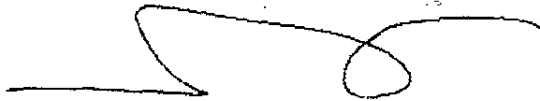

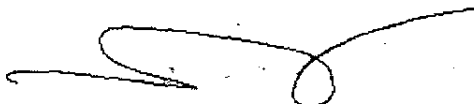
