ARTICLES OF AMENDMENT

TO THE

ARTICLES OF INCORPORATION

OF AVAIRPROS, INC.



1. Pursuant to the provisions of Section 607.1006, Florida Statues, this Florida profit corporation adopts the following amendment to its Articles of Incorporation.

Article III – STATED CAPITAL – the corporation is authorized to issue 150,000 shares of non-voting Common Stock, 150,000 restricted shares of non-voting Common Stock, and 10,000 shares of voting Common Stock. Each share of Common Stock shall have a par value of 25 cents (\$0.2500).

Shares of Common Stock may be issued for such consideration, having a value not less than the par value of the shares issued therefore, as is determined from time to time by the Board of Directors, to be paid, in whole or in part, in cash or other property, tangible or intangible, or in labor or services actually performed for the Corporation. Shares of Common Stock may not be issued until the full amount of the consideration therefore has been paid. Thereafter, such shares shall be deemed to be fully paid and non-assessable.

- 2. The foregoing amendment to the Articles of Incorporation was unanimously adopted by the Board of Directors on August 1, 2018.
- 3. The number of votes case by the Shareholders of the Corporation to amend the Articles of Incorporation was sufficient for approval.
