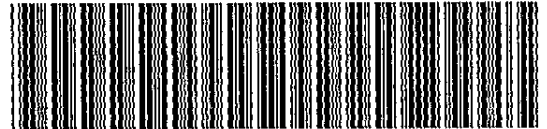



**ARTICLES OF INCORPORATION**  
**OF**  
**C. & R. GENERAL CONTRACTORS, INC.**

ARTICLE I--NAME

The name of this Corporation is C. & R. GENERAL CONTRACTORS, INC.

ARTICLE II--ADDRESS

The street address of the principal office of the Corporation is 7014 A.C. Skinner Parkway, Suite 290, Jacksonville, Florida; and, the mailing address of the Corporation is 7014 A.C. Skinner Parkway, Suite 290, Jacksonville, FL 32256.

ARTICLE III--SHARES

The Corporation is authorized to issue ten thousand (10,000) shares of common stock.

ARTICLE IV--INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is 7014 A.C. Skinner Parkway, Suite 290, Jacksonville, Florida, and the mailing address is 7014 A.C. Skinner Parkway, Suite 290, Jacksonville, FL 32256. The name of the initial registered agent of the Corporation at the foregoing address is ALLEN R. LIESER.

ARTICLE V--INCORPORATOR

The name and address of the incorporator is ALLEN R. LIESER, 7014 A.C. Skinner Parkway, Suite 290, Jacksonville, FL 32256. The powers of the Incorporator shall terminate upon the filing of the Articles of Incorporation with the office of the Secretary of State (Florida); provided, however, that pursuant to Fla.Stat. section 607.0205(b), within a reasonable time following the filing of these Articles of Incorporation, the Incorporator, by written consent, shall name an initial board of directors, consisting of at least one (1) but not more than five (5) directors, who shall complete the organization of the Corporation.

ARTICLE VI--INITIAL BOARD OF DIRECTORS

The members of the initial board of directors shall be named by the Incorporator as provided in Article V, above.

The number of directors shall be fixed from time to time by resolution or written consent of the Board of Directors, but (subject to temporary vacancies) in no event shall there be less than one (1) director. If a vacancy in the Board of Directors occurs during a term, the remaining directors, by affirmative vote of a majority, shall elect a director to fill the vacancy until the next meeting of the shareholders.

## ARTICLE VIII--AMENDMENTS

The Corporation reserves the right to amend or repeal any portion or provision of these Articles of Incorporation, or any amendment hereto, by a majority vote of either the shareholders or the Board of Directors.

IN WITNESS WHEREOF, the undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, has executed these Articles of Incorporation, and does certify that the facts herein stated are true and correct, this 30th day of November, 2005.
