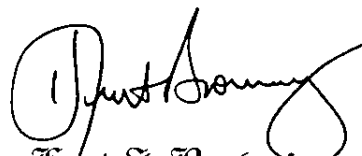
CERTIFICATE OF ADMINISTRATIVE DISSOLUTION
