The Articles of Incorporation of Sunshine Performance Glass, Inc. are hereby amended and restated as follows:

ARTICLE I

The name and address of this corporation shall be: SUNSHINE PERFORMANCE GLASS, INC., P. O. Box 15216, Tampa, FL 33684-5216.

Purposes

The corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

ARTICLE III Stock

The corporation shall have two classes of stock of which the maximum number of authorized shares outstanding at any one time shall be:

- (a) 100,000 shares of Class A Voting Common Stock, with a par value of \$1.00 per share, which shall be designated as Class A Voting Common Stock.
- (b) 100,000 shares of Class B Voting Common Stock, with a par value of \$1.00 per share, which shall be designated as Class B Voting Common Stock.

Class A Voting Common Stock and Class B Voting Common Stock shall be identical, except for differences in voting rights as set forth in the corporation's Bylaws.
